CELEBRATE CHRISTMAS WITH IL DIVO MULTI-PLATINUM GROUP ANNOUNCES INTIMATE, LIMITED-RUN HOLIDAY TOUR *Special Guests Include Holly Cole & Anne Akiko Meyers*

Atlantic City, N.J. – November 10, 2009; One of the world's biggest musical groups Il Divo announced a series of intimate shows entitled *Celebrate Christmas with Il Divo*, a limited-run holiday tour that will kick off in London on December 7, and travel to Toronto, Atlantic City, NJ, Wallingford, CT and New York City. This is a first-ever for Il Divo who have performed holiday songs in front of The Queen of England and past U.S. Presidents, but never before a concert audience.

Celebrate Christmas with Il Divo will perform in the Mark G. Etess Arena at Trump Taj Mahal on Saturday, December 12, 2009. Show time is 8:00 pm.

During the holiday-themed shows, Il Divo will perform songs in three languages (English, Spanish and Italian) from the group's double platinum album *The Christmas Collection* and their recent album *The Promise* including stunning renditions of *Silent Night*, *White Christmas* and *O Holy Night* as well as inspirational favorites such as *Amazing Grace* and *Ave Maria*.

Il Divo will be joined by revered local orchestras - featuring 37 players - in each city such as the Royal Philharmonic Concert Orchestra in London and the Opera Orchestra of New York. The Atlantic City performance will feature very special guests, jazz vocal sensation Holly Cole and international star violinist Anne Akiko Meyer. Il Divo is preparing several new holiday songs as well.

Il Divo will complete their largest worldwide tour to date *An Evening with Il Divo* in November; the massive trek has brought them to 81 cities and 32 countries and was named one of the top 10 grossing tours of 2009 by U.S. trade magazine *Pollstar*. *An Evening with Il Divo* supported the group's fifth album *The Promise* which debuted at #1 in nine countries and marked their biggest opening first week sales ever in the U.S. A live album and DVD are being planned as a result of this tour.

Il Divo is comprised of American tenor David Miller, popular French singer Sebastian Izambard, Swiss tenor Urs Buhler, and Spanish baritone Carlos Marin and were initially brought together by pop impresario Simon Cowell in 2004, following an extensive worldwide audition process. The virtuoso blending of operatic technique with romantic

and popular song took the world by storm, with sales of over 22 million.
